Welcome Words

GIMUN was created in 1999, 20 years ago, as a project that brings together students interested in international cooperation and multilateralism. From the beginning, GIMUN organized a large annual conference simulating the intricate processes behind the decision-making of the United Nations. Since then, GIMUN has expanded considerably.

This term, the student's NGO has started its activities with the Intergenerational Dialogue, an event organized together with Greycells, an association of retired functionaries of the United Nations.

On October 28th, GIMUN organized UN Day, celebrating the entry into force of the UN Charter. More than 80 students from the University of Geneva and the Graduate Institute had the chance to participate in four different panels. The overarching topic of "Taking Action in a World in Movement" and the panels on migration, children's rights, protection of artistic heritage and on the transition towards a nonproliferation and disarmament zone reunited a students with different backgrounds.

In March, we simulated six committees at the very heart of multilateralism - the Palais des Nations in Geneva. We celebrated the 20th anniversary of our conference with a simulation of the UN Security Council, ECOSOC, Human Rights Council, UNEP, CCPCJ and DISEC. Gathering more than 200 participants chairs, journalists, photographers, delegates, and translators – the USGs. interpreters united students with different conference academic background from around 50 different countries.

We also organized, like in the years before, our "MUN Delegation", allowing students from the University of Geneva and of the Graduate Institute to get to know the functioning of the United Nations over a span of multiple weeks. This year, we send a delegation to BIMUN, a new partner conference based in Bonn, but we also had delegates participating in other conferences during the year, most notably SGMUN in St. Gallen, ZuMUN in Zurich and EuroMUN in Maastricht.

The 20th Annual Conference of GIMUN took place from the 25th to the 30th of March 2019 at the University of Geneva and at the Palais des Nations in Geneva. Our Annual Conference is our biggest event every year, attracting around 300 participants in total every year. The work for the conference has already started in July 2018 with the recruitment of the Under Secretaries General. This year, we were able to count on the dedication of 15 highly motivated students and young professionals that worked in one of the domains of GIMUN: Committee Management, with Mihail Mouhlov and Thiago Söthe, Human Resources with Jenny Lam and Federica Vitale. Cultural Events with Asmita Schoettli and Federica Stefanelli, Logistics with Cindy Bischofberger and Taner Toraman, Press with Fernanda Sapiña, Martina Tisdall and Gabriela Taveras as well as Translation with Nicole Rosenberg. Last but not least, we were able to count on the indispensable expertise and tireless efforts of our Interpreting team, which was led by Gaspar Obregon, Camille Collard and Yann Pelikan.

Our Annual Conference has started with the registration day on Saturday, the 23rd of March. We welcomed our participants at the oldest building of the University of Geneva, Uni Bastions. The registration day also featured workshops for beginner delegates as well as an afternoon full of mock debates to let the participants prepare themselves for the "real deal", starting on Monday. We finished the day with our welcome ceremony where we introduced the delegates to the organizing team. The welcome ceremony was followed by a dinner buffet and drinks, a perfect opportunity for everyone to get to know each other in an informal environment.

On Sunday, we organized a city tour in Geneva to give delegates and organizers that were not familiar with Geneva to explore the city and learn about its history.

The conference formally started on Monday, the 25th of March, with our opening ceremony. Held at the UN, we welcomed Michael Møller, Director General the United Nations in Geneva and Oliver Hoehne of the DFAE. After the opening ceremony, the participants were able to profit of a short lunch break and then launch themselves straight into the debate.

Our week at the Palais des Nations resulted in a total of 11 resolutions, one for each topic, hundreds of new friendships connecting people from all over the world as well as priceless memories.



For the Annual Conference of 2019, Cindy Bischofsberger and Taner Toraman were the two Under-Secretaries-General of Logistics.

We began the preparations for the conference in September 2018 by creating an overview of all the tasks that had to be fulfilled, which we then assigned between the two of us. The biggest tasks were as every year the goodies, the dinner on Saturday, the coffee breaks, organising accommodation for participants, printing of all the paper work, the search for sponsors, organisation of the lunch vouchers and supporting other departments.

We pursued last year's project of "GIMUN (Airbnb) Hosts". where we searched for participants living in Geneva who would be interested in hosting participants coming from elsewhere. These participants coming from far away would then be able to stay in expensive Geneva by paying very little. However, it proved exceedingly difficult to find hosts in Geneva and this aspect of the project needs to be improved going forward into the future. Nonetheless, the participants who wished to pay as little as possible for their stay still had the option of staying at the "dortoir aux evaux".

Furthermore, we contacted Uber to have a code especially for GIMUN so that our participants could have a reduction on their rides all around the city.

During the conference we continued to assist and support the participants and other departments to ensure that the Annual Conference would be the best possible experience for everyone. We helped out wherever we could, delivered goodie-bags, badges and placards to participants having arrived late.

The Translation Team for GIMUN's Annual Conference has three main objectives: 1) to ensure that all documents essential to the conference are produced in both French and English, and 2) to provide translators with firsthand experience on the operation of the United Nations, and 3) to shed light on the work done by translators.

For the first time this year, the names of each of the translators were featured on the cover page of the Committee study guides. Although this may not seem very significant, more often than not translators are often invisible in the writing process and as a result rarely receive the recognition they deserve. This small gesture represents a major stepping-stone for translators and will hopefully shed more light on the work they do.

Given that the majority of the work done by the translation team is carried out before the conference, recruitment started very early on. The recruitment process included a translation and revision test in order to select the best candidates. This year the team was made up of three French-to-English translators and ten English-to-French translators. The translators were from Belgium, Canada, France, Switzerland, United Kingdom and the United States. Their responsibilities included translating and proofreading study guides, rules of procedure and creating glossaries for the respective Committees.

Unfortunately, due to the room allotment during the conference only four of the six Committees were fully bilingual. Both the Security Council and the Commission on Crime Prevention and Criminal Justice held debates and drafted resolutions in English.

During the conference, the translators wrote summary records, helped delegates draft resolutions and translated press articles, resolutions and amendments. The entire team delivered accurate and well-written translations under extremely tight deadlines and under minimum supervision. Towards the end of the conference, they spent many hours translating into the wee hours of the morning. Thanks to their hard work, motivation and dedication, the documents were always available on time and the conference went off without a hitch.



Interprétation

L'unité d'interprétation de GIMUN a un objectif double : premièrement, permettre à la conférence d'être bilingue en assurant en direct la traduction orale des débats. En second lieu, faire vivre étudiants de cette discipline ce qu'est le quotidien d'un interprète de conférence.

L'interprétation de conférence est enseignée à niveau Master ou post-master. Les débouchés pour les diplômés présentant une combinaison linguistique pertinente sont variés et destinent à des carrières dans les grandes villes où sont nombre implantées d'organisations internationales: on peut notamment citer Vienne, Genève, New-York pour la famille onusienne, Bruxelles, Strasbourg et Luxembourg pour les institutions de l'Union européenne. Cette année. notre unité accueillait 20 étudiants issus de France. d'universités de Belgigue, du Royaume-Uni et de Suisse.

Les encadrants ont pu dépeindre leur quotidien au service de la communication pour le compte de leurs employeurs et clients, tels que l'ONU, l'UNESCO, la FAO, l'OCDE, l'OTAN, l'UE, le Parlement du Canada. etc. Le taux d'encadrement de 1 professionnel pour 3 étudiants distingue le projet des autres stages destinés aux étudiants interprétation. en

UN Day

UN Day celebrates the signature of the United Nations Charter. This year, GIMUN celebrated UN Day on the 29th of October under the overarching theme of "Taking Action in a World in Movement."

Our first panel, on the topic of migration was led by Dr. Manuel Carballo, executive director of the International Center for Migration health and Development. Migration is an increasingly important topic in international politics. With the Arab Spring and the subsequent outbreak of the Syrian civil war, migration and especially the migration of refugees have been in the spotlight of the media. Migrant flows to Europe opened a heated debate on human rights.

Our second panel on children's rights was led by Professor Margareta Baddeley. Minors are often the most vulnerable to conflict situations. Particularly in the context of migration, it is important to protect the rights of children, especially the right to food, water, safety and education.

Our third panel, on the protection of artistic heritage in times of armed conflict, was led by Professor Marc-André Renold. In times of armed conflict, the protection of cultural heritage is crucial. Not only does the destruction of cultural heritage sites have a negative effect on the civil population in a conflict zone, the illegal trade of cultural objects is also often aiding terrorist groups.

Our last panel was led by Reichard Lenanne, Executive Director of the Geneva Disarmament platform. The concept of disarmament was first brought up in pacifist circles over a century ago. After World War II, disarmament and nonproliferation have risen to a new importance in the context of the Cold War and the threat of nuclear weapons. Non-proliferation zones and disarmament are now more than ever of great importance.

This term, the MUN Delegation was led by the head delegates India Belgharbi and Vanina Meyer. During the sessions, the students discussed the topic of "Promoting the education of girls to empower women in politics and society", simulating UN Women. To prepare the students for participating in the conference of Bonn International Model United Nations (BIMUN), we used their rules for procedure.

In the Autumn semester of 2018, GIMUN sent 6 delegates to BIMUN, covering their participation fee. We also sent a delegation to the conference of St. Gallen MUN in Switzerland.

In the Spring semester, we switched from a more general introduction to MUNing to a series of seminars with the objective to prepare students for their participation in GIMUN. The seminar was led by Jaqueline Wendel and Konstantina Nathanail, the chairs of the Security Council during the Annual Conference 2019.

Besides celebrating the 20th anniversary of the GIMUN association, the Public Relations department of 2018–2019 also celebrated its 10'000 follower milestone on Facebook, as well as some important administrative changes.

This term, the public relations department consisted of Natalie Joray, PR director, Bruna Perestrelo, Vice-Director and Marie Hourdequin, Translator. The department has also been assisted by the photographers Dasha Mai and Louise Méresse during the Annual Conference.

Besides the day-to-day tasks of the department, we have also carried out new projects with the goal of making the work of the department easier. In November 2018, we have migrated our e-mail accounts to G Suite, after having our emails hosted by Infomaniak since around 2011. In February 2019, we have reached the long awaited 10'000 follower milestone on Facebook.

While not quite finished by the end of the term, we have spend countless hours writing, correcting and translating website content. This term has also brought us some new partnerships with other conferences such as POLMUN and BIMUN, as well as an improvement of previous partnerships, most notably CologneMUN and HamMUN.

Rapport Financier

FINANCE DIRECTOR

Cette année 2019, GIMUN a célébré ses 20 ans. L'organisation peut à cette occasion se féliciter à nouveau d'avoir mené à bien sa mission, à savoir proposer à la communauté étudiante de Genève et de bien au-delà des évènements lui permettant de combler sa curiosité pour les Nations Unies ainsi que pour le débat diplomatique. À cette première satisfaction s'ajoute celle de laisser une organisation en bonne santé financière. Il faut à ce titre féliciter le travail du comité et de tous les membres de l'association, de même que la générosité des partenaires financiers.

Le résultat de l'exercice 2018-2019 est le suivant : le prochain comité pourra entamer son mandat avec un capital propre de CHF 10'237.-. En raison de l'incertitude quant aux fonds que nous allions effectivement recevoir de nos différents partenaires, nous avons mené une politique budgétaire conservatrice, limitant au maximum les dépenses, ce qui explique ce résultat.

Il convient de souligner un élément du contexte de cet exercice 2018-19 qui a eu un impact sur nos résultat financiers. En effet, nous avons cette année à nouveau eu cinq jours de conférence aux Nations Unies. En raison de tension entre le calendrier académique de l'Université de Genève et celui des Nations Unies à Genève nous n'avions eu que quatre jours à l'ONU l'année dernière. Pour modérer l'impact de ce retour à cinq jours, nous avons décidé de n'avoir qu'un jour de préparation à Uni Bastions, au lieu des deux habituels. Cette modification nous a permis de faire des économies sur les importants frais de sécurité. Il était difficile d'estimer l'impact de l'augmentation de la durée de la conférence sur le coût des salles. Nous avons donc prévu large. Les coûts n'ont finalement pas été beaucoup plus élevés que l'année précédente. En ce qui concerne les événements culturels de la conférence annuelle, nous avons ajouté une soirée par rapport à l'année dernière : la soirée karaoké. Le coût de celle-ci était raisonnable (chf 700.-). d'autant plus que les participants ont payé eux-mêmes leurs consommations. Afin de compenser l'ajout de cette soirée, nous avons décidé de ne pas fournir de repas le jour du tour de Genève. Cela nous a permis de rester dans les marges budgétaires prévues et même de légèrement réalloué le budget entre les différents événements, en faveur notamment de la soirée fondue et du club night. Enfin, concernant les dépenses sociales et éducatives, nous n'avons malheureusement pu accueillir qu'un seul participant au bénéfice du soutien financier. En effet, les autres nous ayant envoyé leurs dossiers trop tardivement, il était impossible pour nous ainsi que pour le Solidarity Fund de les examiner avant la Conférence. Nous mettrons en place toutes les précautions nécessaires à l'avenir pour que les postulants à l'aide financière puissent participer à notre Conférence.

Concernant les autres événements organisés par GIMUN, UN Day a cette année encore été un succès, les participants étant très satisfaits des interventions et des panels. En outre, nous avons organisé deux conférences en partenariat avec l'association Greycells. Nous nous félicitons des excellents rapports que nous entretenons avec cette association d'anciens diplomates et ferons de notre possible pour que davantage de membres de GIMUN participent à nos événements communs.

Evidemment, rien de tout cela n'aurait été possible sans la générosité de nos sponsors. Cette années encore nous avons bénéficie de l'aide de Présence Suisse. Cet organisme responsable de l'image de la Confédération à l'étranger, a permis à GIMUN d'offrir aux participants de notre Conférence Annuelle, des petits cadeaux représentant la Suisse ; ceux-ci ont été grandement apprécies. L'Institut des Hautes Etudes Internationales et de Développement, a fortement contribué au succès de cette année. Au-delà de l'importance capitale de sa contribution financière, le fait d'être associé à un établissement si prestigieux est pour nous une source de fierté.

L'Université de Genève nous a apporté une aide précieuse, mettant des fonds ainsi que des locaux à notre disposition. La Ville de Genève elle-même nous a également soutenu. C'est avec plaisir que nous constatons que notre activité a toujours la considération de cette dernière, Genève faisant partie intégrante de l'identité de GIMUN. Finalement, le Département Fédéral des Affaires Etrangères nous a une nouvelle fois gratifié de son soutien.


Rapport Financier
